



## WAIVER/PHOTO CONSENT/ INDEMNITY AGREEMENT

I hereby permit Elm Grove Lutheran School and/or its agents to take my child (ren), to functions, lunches, sports outings, and other field trips beyond the campus. I understand I will be given prior notification of such field trips. In the transport of my child to and from these activities, I release you from any and all liability in the event my child is injured during an accident associated with Elm Grove Lutheran or its agents.

In the acceptance of my child as a student at Elm Grove Lutheran and having satisfied myself that supervision and attention to safety are prudent and reasonable. I agree to indemnify, defend, and hold harmless Elm Grove Lutheran and its agents, employees, and representatives against any and all claims and demands (including legal fees) made by me, my spouse, or the legal guardian of the child on behalf of the child.

In case of illness or accident I give Elm Grove Lutheran permission to provide any emergency care for my child deemed necessary, including, but without limitation, treatment by public or private facilities or personnel. It is understood that a conscientious effort will be made to locate me (or the emergency contact persons designated by me) before any action is taken. I accept and agree to pay any charges incurred by Elm Grove Lutheran in such care.

If my child has a clinical health condition (e.g., severe food allergies, asthma, diabetes, or seizures), I am responsible for submitting a Care Plan which stipulates special needs prior to the first day of school.

I hereby permit Elm Grove Lutheran to allow my child to view television and videos within reasonable limits as deemed beneficial to the class. Viewing will be done in accordance with the curriculum, with a specific learning purpose and/or recreation. I understand videos shown to my child will primarily be "G" rated. If any are "PG" rated or unrated containing sensitive materials, I will first receive a separate form by which I give my permission. During computer classes, I understand my child will have supervised access to the Internet for educational purposes, and will be given instruction and admonition as to what is appropriate for Christians to view on-line. Any child who fails to use the Internet in a responsible, ethical, efficient, and legal manner will have his/her access revoked.

I understand that Elm Grove Lutheran School is not responsible for items my child (ren) brings to school that are lost, stolen, or broken while on school premises.

We sometimes take photos during the EGL school day or at school special events. Those photos are occasionally used in brochures, school publications, or on our website. By law, minors must have parental consent before their photos can be used. That law applies also to artwork, video, written work or the student's recorded voice. We will not identify your child except by first name in any publication or on the website. Information such as the child's last name, address, phone number or e-mail address is never included. Photos may be reused in future years. If there is ever a photo you do not want used, we will honor that request. You may revoke this permission at any time by notifying the school office. This agreement does not include the school yearbook. We do not pay for use of photos. We do not have control over photos that might be taken by a newspaper reporter covering a school event. In that case, the newspaper will contact you for permission to use your child's photo.

YES, I hereby give permission for my child (children's) photos, written work, artwork or recorded voice to be used by Elm Grove Lutheran School for public relations purposes. I understand that his or her name and other identifying information will not be used. (PLEASE CHECK YES OR NO)
